2. Declarations of Interest

3. Minutes of the Council Meeting held on Tuesday 10 December 2019

3.1. Approval

These had been pre-circulated with no comments arising. It was **RESOLVED** (unanimously) that the Minutes of the Parish Council Meeting held on 10 December 2019 be confirmed as a true record and be signed by the Chair.

3.2. Matters arising from the minutes (non-agenda items)

- (3.2) Highways matters raised by Councillor Crown have been included into Parish Council's submission for works to be done on Rangers February visit
- (3.2) Coastal Futures Initiative Councillor Lawton had received a letter which he will send to Councillor Devereux
- (3.2) Footpaths Project Parish Clerk reported that he had received an Information Pack from Su Waldron (Project Officer NCC) and an invitation to attend a Seminar on 28 February at Thompson
- (3.2) SAM2 Parish Clerk confirmed delivery had been taken. Councillor Burton confirmed that SAM2 and monitoring equipment had been installed and made operational in Beach Road (3.2) CPRE Parish Clerk confirmed that annual subscription had been renewed at a cost of £36.00
- (4.1) Planting of 1 million trees Parish Clerk had contacted Richard Fisher (Arboricultural Officer KLWNBC) who confirmed a meeting with NCC officers was scheduled for 28 January after which information would be issued for how Parish Councils could get involved

(11.1) SNAP (Safer Neighbourhood Action Panel) — agreed that Councillor Crown would represent the Parish Council at the next meeting. An item that needs to be raised is how traffic accidents are recorded statistically.

4. Reports

4.1. County Councillor and District Councillor Reports

Councillor Lawton informed the meeting that there was nothing to report from the Borough Council. He had received a complaint about a broadband failure from a village resident. It was noted that despite an improvement following the network upgrade broadband problems were still fairly common in Holme.

4.2. Neighbourhood Plan update

Nothing new to report as examination still in progress. Feedback expected late January / early February.

4.3. Cooperative working with neighbouring Parish Councils

Initial meeting to be held on 23 January with attendance confirmed from Brancaster, Old Hunstanton, Ringstead and Thornham. Councillor Lawton requested that representation from area covering Scolt Head be sought. Councillors Felgate, Burton and Crown expressed an interest in attending.

 Member of the public reported an interrupted power supply issue recently. Councillor Felgate reported that this had been due to a power cable falling down in the Thornham area.

New Project Coordinator appointed. Next meeting of Management Board is 19 March 2020. WNNMP often receives information in advance of other bodies so judged to be a useful forum.

Parish Clerk to check if Councillor Amies wishes to represent Parish Council. Councillor Crown offered to be a reserve

Control of dogs

Parish Council had received a report about dogs being walked on village roads without a lead which had caused concern for animal welfare. Parish Clerk had investigated law relating to this and found that the Road Traffic Act 1988 Part 1 Section 27 paragraph 1 states that it is an offence for dogs not to be on a lead whilst on a designated road. Agreed that Parish Clerk should issue a VIN advising of this and place on Agenda of Saxon Shore Parish Forum for discussion

Disposal of green garden waste

Councillor Crown had observed recent incidents where waste had been "fly-tipped" in the village by both householders and contract gardeners

Agreed that Parish Clerk should issue a VIN detailing how green garden waste should be disposed of in an environmentally responsible and legal way

• Quad bike driven on beach and dunes

Councillor Crown had seen a quad bike being driven on Holme beach and dunes between Christmas and New Year

Parish Clerk to bring matter to attention of Le Strange Estate with suggestion to modify existing signs

• 30mph speed limit within village

Chair

Parish Clerk had received a request from a resident for more 30mph signs to be erected to enforce the local speed limit. Concern expressed about Eastgate where many driveways present a hazard to speeding vehicles. Parish Council not authorised to place additional signs without consent of NCC Highways. Parish Clerk advised of the various schemes and processes required to enforce speed limits.

Parish Clerk to report back to resident and include issue in a list of items to be discussed with impending meeting with NCC Highways officer
